






01. The questionnaire was jointly developed by the Summer School organizers - Gorno-Altaisk State University and Siberian Federal University. It was designed with the help of Google Forms and conducted online.

- **02.** The questionnaire was distributed to the participants some time after the event took place. The organizers did it intentionally, as they wanted to give the participants time to reflect on their experience and not to follow immediate emotions. Totally 30 participants provided their feedbacks. The online survey was fully anonymous.
- **03.** The questionnaire was conducted in order to collect participants' comments and feedbacks about the School, carefully analyze them, and discuss obtained results in the group of organizers from both universities to improve the quality of similar events in the future.
 - **04.** The questionnaire consisted of 17 questions.










- 5. Was there an airport/railway station pickup service provided by the organizers?








11. Do you have any wishes and recommendations concerning the overall organization of the Summer School? (openended question)

- Most participants commended the overall organization of the event:
 - ✓ Very nice and productive

 - ✓ To have more participants from different countries and more financial resources to cover their expenses.










14. What case study group were you in?
















16. What new knowledge and skills have you personally acquired as a result of your participation in the Summer School?

- A. Deeper theoretical knowledge on sustainable development goals and sustainability indicators for mountain socio-ecological systems, including vulnerability indicators, and their social aspects
- B. Deeper theoretical knowledge on challenges faced by mountain areas in the context of environmental change and possible solutions to address them
- C. Deeper theoretical knowledge on the principles of the development of ecological and institutional monitoring (including citizen science)
- D. Improved skills for the work in multidisciplinary and international teams and the attainment of agreements on challenging issues





17. Do you have any wishes and recommendations for the improvement of the training process within the framework of the Summer School? (open-ended question)

Among the most important recommendations were:

- Better preparation of the materials (maps, etc.) and equipment (GPS, increment borers, etc.) for the field part;
 - More engagement of group leaders with the participants;
 - To visit more diverse places for case studies;
 - To make lectures more interactive; and
 - To hold the School on a regular basis.
- **05.** In general, judging by the questionnaire, the Summer School-2018 was organized quite well and most participants really enjoyed it. Though, some important comments should be taken into account:
- to arrange preliminary online group meetings (via Skype or Zoom) with the potential lecturers and group leaders in order to discuss how to make their lectures more interactive and prepare necessary handout materials in advance;
- to inform participants about the available equipment and/or possibility to bring and use their own tools in advance;
 - to search for additional funding to support more international participants.
